The man told the Weeks that the Vruwink family was going to hire two "Big Lawyers from Madison" and take care of the Weeks. He stated that all of the Vruwink relatives were coming from as far as Minnesota to meet at the Vesper Shelter Building to determine a proper course of action for dealing with the Weeks.

The second phone call came on 8/25/95. Brenda stated that in this call the caller did not identify himself/herself; however, he/she stated to the Weeks "Is Jody Week your brother?"

When the conversation dictated that Jody Week was in fact relation, the caller stated "I think you have your killer there." There was also mention made of newspaper article that has recently been in the Wisconsin Rapids Daily Tribune which detailed some of Jody Week's recent problems with law enforcement.

8/30/95 - Brenda Week reported that she received a copy of the newspaper report that was mentioned in the telephone call. This prompted her to believe that it was this same person who talked to her on the phone that had sent her the newspaper clipping.

Brenda went on to tell me that she has had a phone trap on her phone through Central State Telephone in Vesper. The 8/25/95 call was trapped to a Jim Vruwink. I believe the "Jim Vruwink" that the call was trapped to is an uncle of Jim Vruwink who is involved with this case. END OF REPORT 9/4/95/DGL

On March 24, 1995 at approximately 6:35P, I responded to the scene of a vehicle versus bicycle accident on County Trunk Highway HH approximately one mile north of STH 186. Upon my arrival, I was briefed by Deputy Starks who had arrived prior to me. This accident involved a young girl being struck by a vehicle while riding her bicycle along CTH HH.

I was advised that the striking vehicle had fled the scene and that the victim had already been removed by St Joseph's Hospital Spirit Helicopter.

The scene had been maintained as it was found by Deputy Starks with the exception of the victim being removed. There were numerous pieces of debris found scattered about the highway which had not been moved, however, there was discussion as to the resting position of the victim's bicycle.

It had been said by someone at the scene that the bicycle had come to rest on the roadway and had been moved into the ditch area adjacent to this position by an unidentified person.

This information had been "passed along" among personnel at the scene and it could not be verified at this time as to where it originated or as to its validity.

My investigation started with plotting different points of the scene by use of the earth-fixed coordinate system. This would later be used to create a scale diagram of the scene.

My measurements started with an origin placed south on the private driveway which was found on the scaled diagram, and the positive axis runs along the pavement edge northbound. The x-y coordinate values are listed on the scene notes page.

Examining the scene starting from the origin, the first significant item found was a small plastic gear assembly piece which had broken from the bicycle upon impact. This item was found at the edge of the private drive, and indicates that impact of the bicycle had to have taken place at this point or more than private drive, and indicates that impact of the bicycle had to have taken place at this point or more than likely prior to this point. This piece may have been carried by the striking vehicle or by its own momentum, likely prior to finally come to rest where it was found, however, it could not have backed up through any forces involved in the accident.

The next items found were a pair of jeans and a plastic bag laying next to one another on the shoulder of the highway. These Items came from the victim. They were followed by a hairpiece which was also lying on the shoulder.

On the surface of the highway was found a straight scrape/scratch measuring two feet in length, followed by a deeper gouge, only a few inches in length. It was determined that the scrape was caused by the rim of the bicycle tire scratching the pavement as it was being pushed by the striking vehicle. This is evident of the bicycle tire scratching the pavement as it was being pushed by the striking vehicle positioning due to the damage that was found on the bicycle and is quite significant in determining vehicle positioning at the time of and just after impact.

The fact that the scrape was straight in nature and parallel to the edge of the highway - just 14° from the highway's edge - indicates that the movement of the striking vehicle was straight in relation to the travel lane. It could also be determined that impact was to the right front of the vehicle due to the fact that no tracks were found in the soft shoulder of the highway. It would be impossible for impact to have occurred that front of the vehicle without the right tires being on the soft shoulder.

The position of the scrape also verifies that the victim was riding her bicycle on the right edge of the pavement, again only inches from the edge.

Had the bicycle been struck in any other area of the roadway, the striking vehicle would have had to immediately have changed positions on the highway to cause the scrape which was found to be on the right side of the road. With the speed of the striking vehicle being estimated at highway speed, this would right side of the road. Some time of skids or yaw marks simply be impossible considering the length of the scene as a whole. Some time of skids or yaw marks would have been present in such a scenario and no such marks were on the highway.

A definite blood stain was found in the ditch where the victim had come to rest. According to Deputy Starks, this would have been the area in which the victim's head was positioned. Between the victim, the location, and the origin were found blood and tissue spatters in the grass. These spatters were only present at the tops of the grass blades and did not show any indication of being smeared or a result of body contact with the ground. The grass in this particular spot was rather long and was not matted down broken down as would be the case from a body contact.

This shows that the victim's body was airborne at least as far as the spatters were found, from the point of impact. There were no signs that the victim's body had contacted the ground prior to its resting point.

This type of occupant kinetics is what would be expected of a victim who is thrown across or over a vehicle's hood and then make contact with the windshield or roof pillars. In this particular case, I believe the victim struck the right front roof pillar as there was no glass found at the scene indicating a windshield break.

Personnel at the Ritchay Funeral Home later advised me that no glass or dust particles were found in the victim's hair after washing, again suggesting that a windshield strike was not involved.

The victim's shoes were found next at the edge of the highway and finally the bicycle, which again has not been verified as its final rest position.

Examination of the bicycle shows that the rear of the bicycle was struck and the rear rim is bent in such a manner as to show that the striking vehicle's bumper partially overrode the rear blcycle tire. This would be consistent with the frame or rim causing a scrape on the pavement as was found, as the striking vehicle be consistent with the frame or rim causing a scrape on the pavement as was found, as the striking vehicle applied any bumper forces the bicycle downward. This would be amplified if the driver of the vehicle applied any amount of braking after impact.

An accurate speed of the striking vehicle seems to be an impossibility at this point. It would be possible to estimate speed considering the distance that the victim traveled airborne, however, many crucial variables are unknown including the exact point of impact and the angle at which the victim departed the striking vehicle.

The aspects of this accident which can be verified by evidence found at the scene, include the position in the vehicles and after impact as well as the direction of travel during the impact. Unfortunately there has been no physical evidence found up to this point which has guided us to the striking vehicle itself.

A short time later David heard what he has described in the past as a loud crash and the sound which he believes was when his daughter was being struck.

I believe both claims have been addressed earlier in the report. We have documentation of Tom Vruwink being at another individual's residence on this particular evening and we obviously have Jim Vruwink within the Vesper area as he was spoken to several times during the course of the investigation and in the days immediately after Deidre's accident.

David also indicated that a venison processor by the name of Norbert Stublaski had told him earlier that someone whom he identified as a Reserve Deputy or a Reserve Investigator on the Wood County Sheriff's Department had come to his venison processing area and made the statement that an arrest was eminent in the Weeks case and that it was only a matter of time before the arrest will take place.

David seemed quite concerned in that the information Stublaski had told him was that Jim Vruwink was not the individual who was going to be arrested.

Week stated that he "laid into him" and peppered him with both obscenities and derogatory statements about calling the Week residence. After doing so David Week stated he hung up.

Week told me that he had also contacted Central State Phone Company in order to obtain any information that had as far as trapping the line. Central State had told Week that they would be contacting me at the Sheriff's Department with any information that they had.

As of late in the afternoon of 12-22-95 I have not received any information from Central State Phone Company.

Upon receipt of information, I will be taking appropriate action against the people who are giving harassing phone calls to the David Week family.

It was also Mr. Week's wish that any type of action that would be possible against these people be done. He seems to be very frustrated at this point in time and I don't really blame him for

- 5. Idsvoog questioned in essence why we were believing Vruwink and not the volume of evidence supplied by the witnesses contradicting his story. He was advised that we are aware of a number of contradiction throughout the full case but we are aware of far more information than he is as to information supporting Vruwink's statement.
- 6. Idsvoog questioned why we never subpoenaed the full "raw" tape from Channel 9 of the Vruwink interview.
- 7. Felt that it was extremely important that Jim Vruwink advised him that he volunteered for a polygraph as opposed to us approaching Vruwink initially and him agreeing to the polygraph. That information was brought forth because of the news article indicating that Vruwink passed the test and therefore did not come under public records denial.
- 8. Most of Idsvoog questions were met with refusal to discuss because of the ongoing investigation. However, certain aspects were responded to because of the obvious incorrect nature of it and felt to maintain integrity of the Sheriff's Department they needed a response.

It was felt that this was a "no-win" situation for the department. This particular tabloid type of journalism will decide what will sell on national TV and will make their program meet their needs irrelevant of the facts of the case.

The initial feeling that this officer got in the direction that the program is taking is to pit Jim Vruwink against other witnesses in the area and draw out the inconsistencies in some of the witness statements and question why in fact this man is not being arrested.





At some point in this disagreement, the topic turned to the Deidre Week case and the fact that the Vruwinks have been questioned concerning it.

Wendy Vruwink stated that Thomas Vruwink became very agitated when Wendy questioned him concerning he or his brothers' involvement in the case. At one point Wendy questioned him concerning the use of a cell phone either during or immediately after the accident, Tom responded to her "You mean the night that Jimmy hit that girl."

Wendy stated when this statement, Tom somewhat "exploded." Once he realized what he had said, he immediately stated to Wendy that he did not mean what he had said and he characterized what he had blurted out in effect as a mistake.

It seems the discussion of this cell phone and the accident is a very "sore point" in the Vruwink marriage. Wendy has questioned Tom's involvement in the case and has received a variety of responses. Once is simply no response.

There are times when Wendy stated to me that she talked to Tom concerning events in the case and he simply will say nothing to her about it. There are other times when they discuss it where Tom becomes very agitated and blames the Investigators on the case and S/A Rehrauer for the problems that he and his brother Jim Vruwink have experienced with the investigation.

On September 6, 1995, at 11:08 a.m., S/A John M. Rehrauer and Inv. Thomas Reichert of the Wood County Sheriff's Department met with and interviewed LORRIE ANN GRIFFITH at her residence, 6794 County Trunk HH, Vesper, WI. The purpose of this interview was to review information GRIFFITH had previously provided to the Wood County Sheriff's Department regarding her observations on the night of DEIDRE WEEK's death on March 24, 1995, and to review a statement as she provided to DAVID and BRENDA WEEK. It should be noted GRIFFITH home is located on County Trunk HH where DEIDRE WEEK's body was discovered in the front yard after a hit and run accident.

LORRIE GRIFFITH was asked to review a 2-page handwritten statement signed by her and dated 08/16/95, which was received by the Wisconsin Department of Justice through DAVID and BRENDA WEEK. MS. GRIFFITH was asked to verify whether this statement was one that she had prepared. After reviewing this statement she did verify that the statement had been prepared by her and the information contained within was accurate.

S/A Rehrauer then asked MS. GRIFFITH whether anyone had asked her to prepare the statement she reviewed. She stated that BRENDA WEEK had contacted her and told her that she needed a statement as to her (GRIFFITH's) recollection involving the hit and run accident involving DEIDRE M. WEEK. She said that BRENDA WEEK only asked her to write down what she recalled about what occurred on the night of the accident to the best of her recollection. She recalled that after she prepared this statement, she dropped it off, with her mother, at the WEEK residence, possibly on the day the WEEK's were leaving to go to Madison, WI to meet with Attorney General Doyle.

MS. GRIFFITH went on to state that on 03/25/95 she had contact with the Wood County Sheriff's Department and provided information to an

officer regarding her observation on 03/24/95. She said that she didn't think anything about her observations on 03/24/95 until she saw a news article on TV-9 involving statements made by JAMES VRUWINK in which VRUWINK mentioned that he had turned into her (GRIFFITH's) driveway on the night of the incident and beeped his horn in an attempt to alert her. She said that this did not occur and was very adamant about it. She stated she eventually provided information to the Wood County Sheriff's Department and the WEEK family which reflected her recollection of what she heard and saw on 03/24/95. She said this was in conflict with JAMES VRUWINK's statements as to what he had allegedly done after observing DEIDRE WEEK's body in the ditch near her home.

S/A Rehrauer then reviewed the handwritten statement that MS. GRIFFITH had prepared in regard to her observations on 03/24/95. The following details information which was not contained within her statement or needed clarification based on information provided She was questioned as to who was at her to law enforcement. residence on the night of the hit and run accident. She stated no one as she lived alone, excepting for her minor child. She said at the time she made the observations her daughter was at her mother's house. She recalled that just prior to making the observations she made she had dropped her daughter off at her mother's to stay overnight as she was working the 10:00 p.m. to 6:00 a.m. shift at Georgia Pacific. She recalled that she arrived back home after dropping off her daughter at about 6:23 p.m. She stated that after being home for approximately 5 minutes she called a personal friend, MELODIE STEEN, who lives in Nekoosa, WI.

MS. GRIFFITH did state that while she was talking on the phone and looking out the sliding glass window, which overlooks the deck on her house, she heard a thud from the south side of the family room wall. She stated that she initially thought something had hit her house. She recalled that when she heard the sound she looked out the window on the south side of the family room and saw nothing. She stated that she then walked into the play room and looked out the window, which would be facing west overlooking County Trunk HH. She indicated that when she looked out she saw nothing, no vehicles, or people. She also commented at this time that she was able to walk around the house freely as she was talking to her friend on a cordless phone.

S/A Rehrauer asked MS. GRIFFITH to compare the thud sound to something that she had heard before. She stated that it was like something hitting a deer. She did state that when she heard the thud she heard no tires squeal or gravel noises from tires. She also commented that while she was talking to MS. STEEN on the telephone she did not have a t.v. or radio on. She did state that the doors and windows to her residence were closed.

MS. GRIFFITH stated that after she heard the thud sound, her attention was focused and if someone would have driven into the

driveway after it, she would have noticed it. She again reaffirmed her prior statement that she did not see a vehicle pull into her driveway after the thud sound nor did she hear a horn honking. She commented that on 03/24/95 she had plastic over the family room window, which was clear, and recalled having the curtains down in the play room.

GRIFFITH went on to state that while she was having a conversation with MS. STEEN and after the thud, she received a telephone call from her mother, MARY SCHULTZ. She stated that she has two-party calling and put MS. STEEN on hold while she spoke with her mother. She said her mother told her that DARRELL LNU , a friend of her mother's who lives on Arpin/Sherry Road, had called her and told her that he had heard on a scanner that a body was in the ditch by MS. GRIFFITH's home. receiving this information from her mother, she heard an ambulance and also saw a van pull up in front of her home. She stated that the van, which was described as blue/silver, were the First She indicated that from her observations the First Responders were a male and female in their 30s. after she made these observations she advised MELODIE STEEN what she had observed and discontinued her telephone call with MS. STEEN and her mother.

MS. GRIFFITH stated that after noticing that the ambulance and van were outside of her house, she walked along the side of her house to see where DEIDRE WEEK's body was. She stated that she observed RANDY BERKHOLTZ and BERKHOLTZ's daughter's boyfriend near DEIDRE WEEK. She stated that she did have a conversation with RANDY BERKHOLTZ and asked what he had seen. She stated RANDY BERKHOLTZ bear her he had seen nothing. She did say that when she told RANDY told her he had seen nothing. She did say that when she told RANDY told her he had seen had heard something prior to the ambulance, BERKHOLTZ stated that he had also.

S/A Rehrauer then asked MS. GRIFFITH if she could recall which vehicle arrived at the accident scene first, the First Responder vehicle or the ambulance. She stated she believed both vehicles arrived at the same time. She said the only other vehicle that she could recall seeing at the accident scene was a van which was could recall seeing at the accident scene was a van which was parked on the west side of the roadway, facing south, just on the parked of the First Responder's vehicle. As part of this interview S/A Rehrauer asked MS. GRIFFITH to accompany him and Inv. Reichert outside her residence to show S/A Rehrauer where she recalled DEIDRE WEEK's body was laying on 03/24/95. After walking out to the front yard on the east side of County Trunk HH, she pointed out a stake by a cross marker was where she recalled some blood being from DEIDRE WEEK's head. She where she recalled some blood being from DEIDRE week's head was then stated that DEIDRE WEEK's head was near this stake and was pointed south with her feet facing in a northwesterly direction.

16 B6 She recalled that when she saw DEIDRE WEEK, she was lying on her back and it appeared that she had a part of her skull lifted or missing. She stated that she watched the EMTs work on DEIDRE WEEK for 5 to 10 minutes, then left the scene and went back into her home as she was somewhat overwhelmed by the sight. She said that when she went back into her residence she believed that DEIDRE WEEK was not breathing.

MS. GRIFFITH said when she went back into her residence the helicopter had not arrived to transport DEIDRE WEEK. She stated after going back into her house she called her mother to advise her of what happened. She also commented that she called her company, who was supposed to be coming out, and told them not to come because of the accident as they would not be able to get near her home. She also mentioned that she called Channel 7 and advised them of the hit and run accident involving DEIDRE WEEK.

MS. GRIFFITH did state that after she went back into her house she did notice that there was a lot of vehicular traffic, both before and after the helicopter came to transport DEIDRE WEEK.

S/A Rehrauer then asked MS. GRIFFITH if she ever saw DEIDRE WEEK's bicycle when she was outside of her residence on 3/24/95. She stated that initially when she went outside she did not notice a bicycle. She said that after being outside for awhile she recalled someone making a comment, "who moved the bicycle". She stated after this comment was made she observed a bicycle on the top side of the east side of the ditch, facing west. She was unable to of the east side of the ditch, facing west. She also commented that while she was walking to her residence she heard cars racing. In concluding the interview, S/A Rehrauer asked MS. GRIFFITH not to discuss this particular interview or the information provided by her with anyone. She stated that she would not. The interview was concluded at 12:00 noon.

The purpose of this interview was to determine her whereabouts, what conversation she had with JAMES VRUWINK regarding DEIDRE WEEK's death, and what observations she made while at JAMES VRUWINK's residence on March 24, 1995. It should be noted that TRACY STALTER currently resides with JAMES VRUWINK and did so on

MS. STALTER stated that on March 24, 1995, she left JAMES VRUWINK's residence at about 8:20 a.m. in a light brown Ford Taurus 4-door with front end damage to the right light and front quarter panel. She stated that she was with her daughter, DANIELLE, and she dropped DANIELLE off at a day care in Vesper, WI, run by ANDREA LOBNER. She said she then went to work, arriving at Coin Builders in Wisconsin Rapids, Wisconsin at about 9:00 a.m.

MS. STALTER did state that she left work at approximately 6:00 p.m. She said she recalled this because she knew this was one of the weekends that they were going to have JIM VRUWINK's children at his home. She said after leaving work, she did pick up her daughter, DANIELLE, at the babysitters in Vesper, and went home. She recalled that she got home around 6:35 p.m., which she indicated was a little later than normal and attributed this to having a conversation with the babysitter when she picked up her daughter. She did state when she got home JAMES VRUWINK was at the residence with his children: ZACH, age 7 and BRITTANY, age 3. that JAMES VRUWINK told her that he had to take a part for a car to vesper.

MS. STALTER was asked whether JAMES VRUWINK provided any detail about his observations of the accident involving DEIDRE WEEK at that time. She said that she could recall no statements being made, other than VRUWINK answering a question his son, ZACH, posed about whether DEIDRE WEEK had died at the accident scene. She did state that she did not specifically see this vehicle, nor did she know whether it was JAMES VRUWINK that drove in. state though that when she came downstairs, after hearing the vehicle drive in, she saw JAMES VRUWINK on the telephone and overheard a conversation about DEIDRE WEEK and the call being a 911

S/A Rehrauer then asked if there was anyone else at JAMES VRUWINK's residence, aside from JAMES VRUWINK, when she returned from work on March 14, 1995. She said that JAMES VRUWINK employs LONNIE (a/k/a VERN) GROSSKRUETZ but didn't recall seeing him on this date when She did state that she knew that LONNIE GROSSKRUETZ had taken the molding strip which JAMES VRUWINK was to have taken to a customer who he sold a car to on March 24, she drove into the driveway. According to MS. STALTER this molding strip never got delivered by JAMES VRUWINK because of his observations of the WEEK She said because of this GROSSKRUETZ had to deliver it She was unable to state specifically when GROSSKRUETZ came to JAMES VRUWINK's residence or whether he was there when she arrived home from work. accident.

S/A Rehrauer asked MS. STALTER how long JAMES VRUWINK's Children were at VRUWINK's residence on the weekend of March 24, 1995. She stated that the children were at VRUWINK's until Sunday about 6:00 p.m. when VRUWINK's ex-wife, KIM KOCIK, picked them up.

S/A Rehrauer then questioned MS. STALTER as to what JAMES VRUWINK had told her later about the accident he observed involving the death of DEIDRE WEEK. She stated that for the first couple of days after the accident JAMES VRUWINK didn't want to talk about it at She said whatever she learned about the accident initally, came from conversation she overheard between JAMES VRUWINK, his

brothers and the police. She then commented that according to JAMES VRUWINK, the accident occurred when he was going to Vesper to take the molding strip for a car he had sold to a customer. S/A Rehrauer also asked MS. STALTER what time she normally got to her babysitter residence in Vesper, WI from work. She stated that

normally it was between 6:15 and 6:20 p.m. She said that if she didn't have any discussion with her babysitter from that point it would take approximately 5 minutes to travel from Vesper to JAMES VRUWINK's residence on County Trunk HH. She stated her route of travel would be north on County Trunk HH out of Vesper, WI.

S/A Rehrauer did question MS. STALTER as to whether she saw any vehicles on March 24, 1995 when she travelled from Vesper, WI to JAMES VRUWINK's residence after picking up her daughter. She stated that she saw no traffic, either north or southbound.

In concluding the interview S/A Rehrauer was provided with a copy of MS. STALTER's time sheet for the work week, March 20-24, 1995. It was noted that this time was a hand written document which showed that on March 24, 1995 MS. STALTER worked from 9:00 a.m. to 6:00 p.m. (It should be noted that MS. STALTER stated that she was responsible for filling out her own work sheet.)

On Thursday, September 7, 1995, at 2:17 p.m., S/A John M. Rehrauer and Inv. Thomas Reichert of the Wood County Sheriff's Department interviewed DEBORAH LYNN DEDERICH at her residence, 6673 Cameron Avenue, Vesper, WI. The purpose of this interview was to determine what information she had regarding conversations while acting as an EMT on March 24, 1995 at an accident scene on County Trunk HH, just north of Vesper, involving a death of DEIDRE WEEK.

DEBORAH DEDERICH recalled that on 03/24/95, she learned about the accident involving DEIDRE WEEK while she and her husband, DENNIS DEDERICH and children were going to Wisconsin Rapids. She stated the original information from dispatch was that a pedestrian had been hit by a vehicle, with the location being given as County Trunk HH, just north of Vesper, WI. She said that after receiving this information, her husband, DENNIS, contacted the Wood County Dispatch and informed them that he and his wife were in service and would be responding to the accident.

S/A Rehrauer asked DEBORAH DEDERICH what type of vehicle she and her husband were driving on the night that they responded to the accident. She stated that they were driving her husband's personal vehicle, a blue GMC truck with no capper.

DEBORAH DEDERICH did state that once she and her husband got to the accident scene with their children, she noted that the rescue truck and fire trucks from Vesper were present. She said that her first observation was seeing a child in the ditch and then vaguely recalled seeing a bicycle. She stated that she did assist in providing emergency medical care to DEIDRE WEEK, along with other EMTs from Vesper.

DEBORAH DEDERICH stated that during the time emergency medical care was given to DEIDRE WEEK, she noticed DEIDRE had the right side of

her head exposed, was flat line, was a non-breather, and had no detectible pulse. She stated even though DEIDRE's medical condition was not positive it was decided to transport her by helicopter, using The Spirit of Marshfield.

According to DEBORAH DEDERICH, this was done so DEIDRE WEEK could get additional medical care in a lifesaving effort at St. Joseph's Hospital in Marshfield, WI.

S/A Rehrauer asked DEBORAH DEDERICH if she knew who the person was she was providing medical care to and she stated that when she first observed DEIDRE WEEK in the ditch, she did not. However, she stated that once she got closer to DEIDRE WEEK, she noticed the costume that she had on and recognized it because of a play DEIDRE and her daughter were both involved in. She stated because of the particular costume that DEIDRE WEEK had on, she knew that the person in the ditch was DEIDRE WEEK.

DEBORAH DEDERICH did recall that she and her husband, along with their children, went to DAVID WEEK's residence after The Spirit of Marshfield helicopter left transporting DEIDRE WEEK to St. Joseph's Hospital in Marshfield, WI. She said that they went to DAVID WEEK's house to update him on his daughter's condition and to assist by offering help in taking him to the hospital to be with his daughter. She recalled that upon arriving at DAVID WEEK's residence, either DAVID WEEK's mother, or BRENDA WEEK's mother were present, along with the WEEK children.

DEBORAH DEDERICH stated that DAVID WEEK did agree to accompany she and her husband to the hospital to see his daughter, DEIDRE WEEK, and they did leave the WEEK's residence with DAVID WEEK riding in their vehicle. She stated while on the way to the hospital DAVID WEEK cried a lot. She also said that DAVID WEEK mentioned that he had gotten a hold of his wife, BRENDA, who would be coming home and then coming to the hospital. She stated that DAVID WEEK also had questions about the care given to his daughter. She said that during the discussion about the care given to his daughter, she felt WEEK acted appropriately. She did comment that on at least one occasion while she and DAVID WEEK were discussing his daughter's care he said, "DEIDRE is dead.".

DEBORAH DEDERICH also recalled that DAVID WEEK did talk about how he was outside just prior to the accident and recalled hearing a noise and looking at his watch and feeling that his daughter, DEIDRE WEEK, should be coming home shortly. She stated DAVID WEEK also mentioned observing a vehicle go by his home and eventually going down the highway and seeing DEIDRE WEEK's bicycle and her going down the ditch. She said that DAVID WEEK also mentioned body laying in the ditch. She said that DAVID WEEK also mentioned that after seeing his daughter in the ditch and going to get help, the left the scene and went back home. She said that DAVID WEEK told her he just couldn't go back to where his daughter, DEIDRE, was and for this reason he stayed home.

50 BIH DEBORAH DEDERICH also stated that while on the ride to the hospital, DAVID WEEK did state that he shouldn't have moved his daughter, DEIDRE WEEK, from her original position. She said that DAVID WEEK mentioned that he moved her from a puddled area in the ditch where she was face down because he didn't want her laying in water.

DEBORAH DEDERICH stated that she and her husband and children stayed with DAVID WEEK in the quiet room at St. Joseph's Hospital until BRENDA WEEK and some of the other family members got there. She stated this was just about the time the family was being allowed to go and view DEIDRE WEEK's body which had been cleaned up by medical personnel. She estimated this would have occurred some 35 minutes after they arrived at St. Joseph's Hospital.

S/A Rehrauer then asked DEBORAH DEDERICH if any of the EMTs at the accident scene on 03/24/95 had been drinking prior to answering the call. She stated none that she was aware of. She indicated that the Vesper Fire Department had a written policy regarding such matters. She added additionally that if someone had been drinking, matters certainly would not have been put in a lifesaving role but instead would have been doing menial tasks at the scene.

Following the interview, S/A Rehrauer, Inv. Reichert, and DEBORAH DEDERICH returned to the scene of DEIDRE WEEK's accident so she could point out where she observed DEIDRE WEEK's body and bicycle on 03/24/95. The following reflects her recollection.

Thomas Reichert of the Wood County Sheriff's Department interviewed DENNIS JAMES DEDERICH at the Vesper Fire Hall, Cameron The purpose of this interview was to determine what information and what observations DEDERICH made on 03/24/95 when he responded as an EMT, along with his wife, DEBORAH, also as an EMT, to an accident scene where DEIDRE WEEK had been hit on her bicycle.

S/A Rehrauer asked DENNIS DEDERICH to explain what he was doing when he responded to the accident scene involving DEIDRE WEEK on March 24, 1995. He stated that he and his wife, DEBORAH, and their children were on County Trunk F, approximately half the way to Wisconsin Rapids when he received a page at about 6:45 p.m. He said that the information provided with the page was that a lady He said the had been struck by a vehicle on County Trunk HH. specific location for the accident scene was given.

DEDERICH said he and his wife discussed the information provided with the page and assessed whether they should return to the Vesper area to the scene of the accident. He said after the discussion with his wife they decided that they should return and they went directly to the scene of the accident involving DEIDRE WEEK. also mentioned that at the time he was travelling in his own personal vehicle and his children also accompanied he and his wife to the scene. He mentioned that he arrived with his wife at the scene approximately 4 minutes after the Vesper Rescue vehicle had arrived.

DENNIS DEDERICH stated when he first got out of his vehicle and observed the person that had been struck he noted that the body was on the east side of the road. He said the person that had been struck, based on his first observation, was a 10-12 year old boy

(later learned it was DEIDRE WEEK). DENNIS DEDERICH did state that DEIDRE WEEK had significant head trauma to the right rear of her head. He recalled there was a lot of tissue loss based on this trauma.

DENNIS DEDERICH said during the course of the emergency medical care given he worked as a gopher while his wife provided hands-on care to DEIDRE WEEK. He recalled some of the things that he did while present at the scene as follows:

- Brought lights down to where DEIDRE WEEK's body was. 1.
- Brought a suction unit down.
- Maintained contact with the Pittsville Ambulance Service, providing status updates on DEIDRE WEEK's condition.
- Assisted in establishing a landing zone for The Spirit of Marshfield helicopter service which transported DEIDRE WEEK to the hospital in Marshfield, WI.

DENNIS DEDERICH did state that prior to The Spirit of Marshfield helicopter arriving at the scene, DEIDRE WEEK had been given care by the EMTs and moved to a Pittsville Ambulance for transport to Marshfield, WI. He recalled that DEIDRE WEEK was not actually transported to Marshfield by the Pittsville Ambulance Service but was actually taken out of the Pittsville Ambulance and transferred to The Spirit of Marshfield helicopter at the scene, for transport to the hospital.

DENNIS DEDERICH recalled when The Spirit of Marshfield helicopter arrived at the scene he asked JAMES VRUWINK to move the vehicle that he was driving across the roadway so that the landing zone for the helicopter would be lit cross-ways with VRUWINK's headlights. He also commented that after VRUWINK's vehicle was used, sometime later in the evening, VRUWINK was unable to get his vehicle started to move it off the roadway.

S/A Rehrauer asked DENNIS DEDERICH if he ever saw a bicycle at the scene. He stated that he had. He recalled seeing the bicycle when he was setting up a landing zone for The Spirit of Marshfield helicopter. He stated to the best of his recollection the bicycle was located to the north of DEIDRE WEEK's body and not beyond the northern most boundary of the landing zone for the helicopter.

DENNIS DEDERICH stated that his first contact with DAVID WEEK on 03/24/95 came when he and his wife, DEBORAH, and their children went to DAVID WEEK's residence to advise what was happening to his daughter, DEIDRE. He stated that when he arrived at DAVID WEEK's residence, WEEK's children, BRANDON and AVERY, were present, as residence, WEEK's children, BRANDON and AVERY, were present, as well as an older lady, possibly WEEK's mother or mother-in-law. DENNIS DEDERICH stated while on the way to the hospital in Marshfield with DAVID WEEK, he did tell them that he had notified his wife, BRENDA WEEK, by telephone of the accident involving their daughter, DEIDRE. He said DAVID WEEK mentioned his wife would be returning to their home in Vesper, WI from Wausau, WI.

He stated because of the information provided by DAVID WEEK, he did make contact with the fire department and had a person dispatched to the WEEK residence for the purpose of bringing BRENDA WEEK to the Marshfield hospital when she returned from Wausau.

DENNIS DEDERICH stated that while on the way to the hospital in his vehicle with his wife and children, DAVID WEEK did state that when he found his daughter she was bleeding a lot. He said that DAVID WEEK commented that he realized that DEIDRE WEEK had been hurt badly.

DENNIS DEDERICH further stated that DAVID WEEK mentioned that when he first came up to his daughter he moved her from the bottom of the ditch because she was laying in water. He stated that he could recall no conversation or discussion he had with DAVID WEEK about his daughter's body position in the ditch.

DENNIS DEDERICH stated he had no discussion with DAVID WEEK while in the quiet room at St. Joseph's Hospital in Marshfield about the accident scene. He did state when DAVID WEEK was notified in the quiet room by the physician that DEIDRE WEEK had died, DAVID WEEK did not seemed surprised and he believed that WEEK had already realized the seriousness of DEIDRE's injuries prior to this.

S/A Rehrauer asked DENNIS DEDERICH if he was aware of any of the EMTs that were on the scene, that possibly had been drinking. He stated not that he knew of.

Following the interview S/A Rehrauer, Inv. Reichert, and DENNIS DEDERICH returned to the scene of DEIDRE WEEK's accident so he could point out where he observed DEIDRE WEEK's body and bicycle on 03/24/95. The following reflects his recollection.

On Thursday, September 7, 1995, at 6:45 p.m. S/A John M. Rehrauer met with and interviewed DAVID J. and JULIE FRAHM at their residence, 1923 9th Avenue, Edgar, WI. The purpose of this interview was to review information the FRAHMs had previously provided to the Wood County Sheriff's Department and the WEEK family by statement regarding their observations on the night of DEIDRE WEEK's death on March 24, 1995. It should be noted that the FRAHMs purchased a vehicle from JAMES VRUWINK on March 24, 1995, with negotiations taking place for the vehicle in the parking lot of a gas station in Vesper, WI, between 6:00 p.m. and 8:00 p.m.

When the interview was started only JULIE ANN FRAHM was present. S/A Rehrauer asked her to review a 4-page handwritten statement which was signed by DAVID FRAHM, JR. and JULIE FRAHM. S/A Rehrauer advised that this statement had been received thru DAVID and BRENDA WEEK who turned it over to the Wisconsin Department of Justice. S/A Rehrauer asked MS. FRAHM to review the statement as to it's accuracy and to verify that she and her husband had authored it. After reviewing the statement MS. FRAHM stated this was a document that she had prepared based on conversations she and her husband had about their observations on March 24, 1995. She stated the information contained within was accurate to the best of her recollection.

S/A Rehrauer then asked when this document was prepared and she stated that she could not recall. It should be noted that this document is undated. She did state that she recalled that she and her husband received a telephone call from DAVID WEEK requesting the document. She said DAVID WEEK did explain that his family was

not satisfied with the investigation conducted by the Wood County Sheriff's Department.

MS. FRAHM said that DAVID WEEK picked up the statement she and her husband had prepared. She stated that when DAVID WEEK picked the statement up he commented that he was going to give their statement to Attorney General Doyle when he met with him in the future.

S/A Rehrauer did ask MS. FRAHM what DAVID WEEK asked them to write within their statement. She stated that DAVID WEEK only asked them to write down what they recalled happening on the evening of March 24, 1995. She stated that she and her husband added as much specific detail as possible.

Prior to continuing the interview, DAVID J. FRAHM came home and S/A Rehrauer had a short discussion with him regarding the 4-page statement reviewed by his wife. S/A Rehrauer asked him to review the statement also and he verified the fact that this was a statement written by his wife which he had provided his input into.

S/A Rehrauer then asked the FRAHMs if they had any contact with JAMES VRUWINK prior to March 24, 1995 in regard to the purchase of the vehicle they bought from VRUWINK on March 24, 1995. DAVID the vehicle they bought from VRUWINK on March 24, 1995 they had FRAHM stated they had. He said prior to March 24, 1995 they had received a telephone call from PERRY FRAHM his uncle who lived in Vesper, WI who knew they were looking for a vehicle. They said that they took the telephone number off of the car and called from PERRY FRAHM's residence to the number on the car in an attempt to get a hold of the owner. They stated that they were unsuccessful in getting a hold of anyone on this date.

JULIE FRAHM said following the above activity PERRY FRAHM was able to get a hold of JAMES VRUWINK and VRUWINK did contact them and set up an appointment the following week to have them come down and see and drive the car. She stated the appointment was set for 3/24/95 at 6:00 p.m.

JULIE FRAHM stated on March 24, 1995, they went to Vesper, WI with their children, to look at VRUWINK's vehicle. They stated that they arrived in Vesper at approximately 5:55 p.m. and went over to they arrived in Vesper at approximately 5:55 p.m. and went over to PERRY FRAHM's as he had indicated an interest in going along with them when they went to drive the car. They stated that they sat in their car for approximately 10 minutes waiting for somebody to show up, after which JULIE FRAHM said that she went over to the gas station to phone the owners of the car. She said that she did get a hold of a gentlemen who indicated the guy would be there in a little while as he had just left.

They stated that they checked out the car and asked a few questions and took the car for a ride around the block in Vesper, WI. They estimated that they were gone for approximately 5 minutes. They said on their return they agreed to purchase the car and did have some discussions with JAMES VRUWINK about a missing chrome trim ring around the wheel. They said they agreed to purchase the car from VRUWINK for \$4,200.

They stated that after they agreed to purchase the vehicle from JAMES VRUWINK, he walked over to the gas station to get a pliers to remove the license plates that were on the vehicle. They recalled after this JULIE FRAHM signed the title to the car and JAMES VRUWINK agreed to get the chrome trim that was missing.

They stated that they had asked JAMES VRUWINK how far he needed to go to get the chrome trim ring and were told that it was about a 2 mile ride. They stated that they offered to follow VRUWINK out to get the trim ring, thinking they would get home quicker if they did. They stated that VRUWINK declined the offer and stated he would be right back. They also recalled JAMES VRUWINK telling them that they needed to gas up the car anyway. They stated this person told them that the guy they bought the car from had witnessed a hit and run accident out on the highway.

They stated after they got the trim ring from the above described person, they left Vesper, WI and drove to a gas station, possibly in Arpin, WI where they waited for a brief period of time. They said they then drove directly to Edgar, WI and stopped at either her parents or his parents to show them the car they had just purchased. They recalled arriving home shortly after 9:00 p.m.

They did state that when they arrived home they watched the news to see if there was any information about the accident. They recalled that there was not and that they learned about DEIDRE WEEK's death on the following day when it was on the news.

S/A Rehrauer did ask whether anyone from the Wood County Sheriff's Department or a private investigator had actually looked at FRAHM's vehicle following DEIDRE WEEK's accident. They stated that no one had, however, they had been contacted by a person they believed was the District Attorney from Wood County, asking about any damage. On Friday, September 8, 1995, at 10:00 a.m., S/A John M. Rehrauer and Inv. Thomas Reichert of the Wood County Sheriff's Department met with and interviewed DAVID M. WEEK at his residence, 6913 County Trunk HH, Vesper, WI. The purpose of this interview was to clairfy and obtain additional information from him regarding observations he made on March 24, 1995 involving the accident which took the life of his daughter, DEIDRE M. WEEK, on County Trunk HH, just south of his residence.

DAVID WEEK stated that on March 24, 1995, he and his son, also referred to as CHARLIE) were home when his daughter, DEIDRE WEEK, left for play practice at about 5:00 p.m. He stated his other son, was not home when DEIDRE left for the play and got home at approximately 5:10 or 5:15 p.m. when he was dropped off by (ph) mother. He said the live off tennas Road. Tenpas Road. * 11.27

DAVID WEEK did recall that prior to his daughter leaving the residence for play practice he gave her \$20 as this was the smallest bill he had, for her to get a treat at Winch's Mini Mart. He stated when he gave DEIDRE WEEK the money she asked if she should also get her brother, a treat also. He said that he told her that she could. He stated there was no conversation as to whether DEIDRE was going to stop for the treat before she went to play practice or after.

DAVID WEEK continued, stating that when his daughter, DEIDRE WEEK, left their residence she was wearing a light colored jacket, green pants, and an unknown colored shirt. He recalled that DEIDRE WEEK had her hair tied back when she left, but couldn't recall with He said that he didn't actually see DEIDRE WEEK leave the driveway of their residence as he was in the kitchen at the time.

7. Special Agents

John M. Rehrauer

DAVID WEEK stated that after DEIDRE WEEK left, he started cleaning the house and doing chores associated with his beef cattle. He recalled that while he was doing dishes he looked up at the clock and noticed that it was 6:20 p.m. and remembered that he was having people over for guitar lessons. He said that he finished doing people over for guitar lessons. He said that he finished doing dishes and walked in the back room and retrieved the pails to feed the dogs. He stated that he then went outside leaving BRANDON inside to watch AVERY.

DAVID WEEK commented that after being outside for about 10 minutes, which he estimated the time then to be 6:30 p.m., he heard a car coming from the north which had a loud muffler. He stated this vehicle travelled south by his residence. He did state that he was vehicle to describe the color or make of the vehicle or possible unable to describe the color or make of the vehicle may occupants. He did state off the top of his head, the vehicle may have been larger. He said at the time he made this observation he was near the drain pipe, which is located at the northwest corner of his residence.

DAVID WEEK stated that after the vehicle went by he noticed that it was dusk and he started thinking about his daughter, DEIDRE WEEK. He said he then heard an impact, which he described as being a tin thud. He said after hearing the impact he heard nothing else. He did state that after hearing the impact, he stopped for a second and thought about DEIDRE and then continued to feed the dogs for approximately the next 3 to 4 minutes.

S/A Rehrauer questioned DAVID WEEK about his recollection of the time. He stated that he had looked at a clock in the kitchen when he was doing dishes and knew it was 6:20 prior to going outside. He further stated that normally he does not keep track of time and mentioned that he does not wear a watch.

S/A Rehrauer did look at the kitchen clock at DAVID WEEK's residence during this interview and noted that the clock was 5 minutes slower than S/A Rehrauer's watch. S/A Rehrauer did verify that his watch was actually 2 minutes faster than the recorded time it showed. This was done through AT&T Time & Temperature.

DAVID WEEK stated that after feeding the dogs he took the pails into the barn and got into his truck. He stated the truck he currently had was not the truck he had at the time his daughter, currently had was not the truck he had at the time his daughter, died. He described the truck he owned on 03/24/95 as a primer red 1976 Chevrolet Cheyenne 4-wheel drive truck. He also stated that this particular truck had no reverse in it. He stated when he got into his truck he was going to go and look for his daughter, DEIDRE WEEK, as he was somewhat concerned as it was getting darker out. He recalled the time which elapse between getting into his truck and the northbound car coming by, going south, would have been approximately 5 minutes.

DAVID WEEK stated that he had not told his other children he was going to look for DEIDRE WEEK when he decided to. He said just after putting his truck into gear, he noticed a car go by in front of him. He recalled his truck was facing north and parked near the silo when the car went by. He described the vehicle that went by northbound as a silver, smaller car, but was unable to provide any information as to the number of occupants in the vehicle and was unsure whether this particular vehicle had its headlights on. did state that after the first vehicle went by northbound, he did move to the end of his driveway and would have been facing east as He estimated that there was a 3-5 second difference between when he saw the first and second car. He stated the second car was possibly a larger vehicle. provide any specific information as to who the occupant(s) of it He did recall that the second vehicle may have had its headlights on. He also commented that he didn't believe either of the two vehicles he observed going northbound were driving in excess of 55 mph.

DAVID WEEK was asked if he noted whether either of the two vehicles that passed him going northbound were blowing their horn. He stated that he didn't believe they were and then commented that his stated that he didn't believe they were and then commented that his truck made a lot of noise because it had headers on it and it might have been different to hear because of that.

DAVID WEEK did state that after the second vehicle passed his driveway, northbound, he did pull out on County Trunk HH and headed south in the direction of Vesper. He said that he saw DEIDRE's bicycle just as he passed Hayes Lane, which is a road which intersects County Trunk HH east, just south of WEEK's residence. He recalled stopping in front of BERKHOLTZs on the west side of the highway and parking his vehicle. He stated that he may have left his vehicle run, but he was unsure. DAVID WEEK then continued stating that when he first observed his daughter in the ditch on the east side of County Trunk HH, her head was facing south and her feet were facing north. He recalled that her hands were down to her side and she was laying on her back in some water. He recalled putting his arms under his daughter's body and holding her, possibly giving her a couple of kisses. He said and holding her, possibly giving her a couple of kisses. He said that he realized that he had to contact someone about his daughter's accident and indicated that he looked over at GRIFFITHS and did not notice any lights on. He stated he then looked over at RANDY BERKHOLTZ's residence and saw what he believed to be one light on in the middle of the house. He said because of this he ran to BERKHOLTZs and knocked on the door two or three times and then let himself in.

DAVID WEEK stated after entering the BERKHOLTZ's residence he asked someone to call 911 and informed that person that his daughter had been hit by a car and she was in a ditch outside. He estimated that he talked to the BERKHOLTZ's for approximately 15 seconds and then left their residence with RANDY BERKHOLTZ's daughter's boyfriend to return to his daughter, DEIDRE WEEK. DAVID WEEK recalled seeing The Spirit of Marshfield helicopter come over County Trunk HH and appeared to be landing. He stated that when he saw this he had a discussion with his son, BRANDON, that when he saw this he had a discussion with his son, BRANDON, and commented maybe there was hope. He said after about one minute that idea passed as he felt DEIDRE had already died based on the injuries that he had seen.

DAVID WEEK stated that after The Spirit of Marshfield left the area the DEDERICHs came to his house and asked him to go to the hospital to attend to his daughter. He said that he really didn't want to go but eventually they coaxed him to, with assistance from his mother. He said that the only reason he was reluctant to go was mother. DAVID WEEK stated that he did accompany the DEDERICHS to the hospital in Marshfield, WI. He recalled that not only the DEDERICHS were in the truck but also their two children. DAVID WEEK was questioned as to whether he had any conversation with anyone at the hospital about his observations when he discovered his daughter's body in the east ditch of County Trunk HH. He said he could recall none.

DAVID WEEK continued stating that since his daughter, DEIDRE's, death he has had many dreams about the accident. He said that currently the dreams end after he discovers DEIDRE's bike. He then commented the hardest part of the dreams prior to this were seeing DEIDRE the way she was.

S/A Rehrauer then questioned DAVID WEEK as to a comment that was attributed to JAMES VRUWINK which occurred at his daughter, DEIDRE WEEK's funeral. He stated that JAMES VRUWINK commented to him, "Oh you were the guy who was coming out of the driveway when I went by.". He stated that aside from him hearing this comment his wife, BRENDA, and his brothers, JODY WEEK, STEVEN WEEK and RANDY WEEK, also heard this.

S/A Rehrauer then asked DAVID WEEK again about DEIDRE's bicycle which he had observed on the roadway. He stated that he recalled that when he went back home, after leaving the accident scene where DEIDRE was, he had to go into the southbound lane to avoid hitting DEIDRE's bike. He stated to the best of his recollection DEIDRE's bicycle was where he first saw it.

Following the interview S/A Rehrauer, Inv. Reichert, and DAVID WEEK returned to the scene of DEIDRE WEEK's accident so he could point out where he observed DEIDRE's body and bicycle on 03/24/95. The following reflects his recollection:

- 1. DEIDRE WEEK's bicycle was located 12 paces south of the last tree on the east side of County Trunk HH from an open field which is located just south of Hayes Lane. The bicycle was approximately 1 foot east of the center line of the north-bound lane of County Trunk HH. DAVID WEEK stated that the front of the bicycle was facing north and the back was facing south.
- DAVID WEEK parked his vehicle on the west side of County Trunk HH, 56 paces south of the center of RANDY BERKHOLTZ's driveway, located at 6824 County Trunk HH, Vesper, WI, after discovering his daughter's body.
- 3. DEIDRE WEEK's body was discovered by DAVID WEEK in the center of the east ditch of County Trunk HH, 17 paces north of the center of LORRIE GRIFFITH's driveway, located at 6794 County Trunk HH. DAVID WEEK stated he moved his daughter's body approximately 1 1/2 feet out of the ditch east toward the up slope of the ditch when he returned from the BERKHOLTZ's residence. He stated prior to this he had not moved his daughter when he first discovered her body.

After making the above observations, S/A Rehrauer and Inv. Reichert returned to DAVID WEEK's residence and while there S/A Rehrauer received two documents as follows:

1. An Ameritech telephone bill for BRENDA and DAVID WEEK which documented a telephone call from DAVID WEEK to BRENDA WEEK at 6:50 p.m. on 03/24/95. DAVID WEEK stated that this call was the one that he notified his wife of his daughter's accident.

On Friday, September 8, 1995, at 1:25 p.m., S/A John M. Rehrauer and Inv. Thomas Reichert of the Wood County Sheriff's Department met with and interviewed RANDOLPH D. and IRENE F. BERKHOLTZ at their residence, 6824 County Trunk HH, Vesper, WI. The purpose of this interview was to have the BERKHOLTZs verify whether a statement signed by them and dated 08/16/95, which was given to the Wisconsin Department of Justice by DAVID and BRENDA WEEK, was prepared by them. Also, additional information was being sought to clarify and expand on information they provided to the WEEK family and the Wood County Sheriff's Department. It should be noted the BERKHOLTZs were the first people contacted about the accident by DAVID WEEK after it occurred on 03/24/95.

Both RANDOLPH and IRENE BERKHOLTZ were given the opportunity to review a 2-page handwritten statement, which was written on both sides of one sheet of paper. This statement was signed by RANDY and IRENE BERKHOLTZ and dated 08/16/95. statement, they concurred that it was true and accurate to the best of their recollection. RANDY BERKHOLTZ did state that he was the author of the statement and mentioned when it was prepared both of them agreed with the contents of it.

S/A Rehrauer questioned the BERKHOLTZs as to what they were doing Just prior to DEIDRE WEEK's accident on 03/24/95. They stated that they had been out for a walk and their daughter, TERRI BERKHOLTZ, They recalled that had accompanied them on her roller blades. their walk involved a circuit whereby they travelled south on County Trunk HH from their residence down to the church near town, then returned home north on County Trunk HH. They estimated that their walk took approximately 15-20 minutes. They recalled that it

was still daylight when they returned and felt that the sun had not set yet.

IRENE BERKHOLTZ stated upon returning from the walk, she and her daughter, TERRI, went into their residence. RANDY BERKHOLTZ said that he remained outside and put his vehicle away in the garage. He recalled while doing the above activity, he thought he saw his brother drive by in a blue Buick, pulling a black trailer, which he felt was owned by his father. He stated that he never confirmed whether his suspicion about the vehicle and trailer were correct.

RANDY BERKHOLTZ did state that MATT MOLNAR, his daughter's boyfriend, arrived while he was still outside. He recalled that MOLNAR was driving a 1984 Ford Mustang, dark gray, with black trim. He said both he and MOLNAR went into the house together, right after MOLNAR arrived.

RANDY BERKHOLTZ stated he and MOLNAR joined his wife, IRENE, and daughter, TERRI, in the livingroom where they were watching television. He said he was unsure whether "The Simpsons" were on yet. Both he and his wife agreed they had seen some of "The Simpsons" on 03/24/95. They both indicated they believed "The Simpsons" television program starts at 6:30 p.m.

RANDY BERKHOLTZ said after sitting in the livingroom for an estimated 5 to 10 minutes he heard a thud, which he described sounded like a car door closing hard. IRENE BERKHOLTZ also said that she heard the same sound. Neither of the BERKHOLTZs were able to say specifically where the sound came from, other than they felt it came from the neighbors to the south, the GRIFFITHS.

RANDY BERKHOLTZ stated they continued to watch television after hearing the thud. He estimated about 10 minutes later he heard the doorbell ring once. IRENE BERKHOLTZ said that he got up and met a male, later identified as DAVID WEEK, in the hallway by the back door, as he had entered their residence. She stated DAVID WEEK told her to call 911 as someone had hit his daughter. She recalled that DAVID WEEK had blood on his hands.

IRENE BERKHOLTZ said that she did call 911 and informed the person answering the telephone that a guy had come to their home and reported his daughter had been hit. She stated at the time she was unable to tell the person she was talking to on 911 whether the person who got hit was walking or riding a bicycle. She said on this initial call she did not provide the dispatcher with her name.

IRENE BERKHOLTZ stated after her husband, RANDY, MIKE MOLNAR, and her daughter, TERRI, had been at the scene of the accident she made another call to 911. She said she relayed some additional information about the accident based on what her daughter told her when she returned to their residence after being at the accident scene. IRENE BERKHOLTZ stated when she called back on the 911

line, she informed the dispatcher that the accident she previously reported was a hit and run, involving a bicycle.

RANDY BERKHOLTZ did state that after DAVID WEEK came into their residence, MATT MOLNAR ran and got his shoes on and accompanied DAVID WEEK outside to where DEIDRE WEEK was. RANDY BERKHOLTZ said that he had noticed that when DAVID WEEK was in his residence, WEEK had blood on his shirt. He stated because he noticed blood on DAVID WEEK, he went and got his shoes and grabbed a blanket off of their bed because he knew DEIDRE WEEK had to be hurt. He stated that he then ran out to the end of his driveway and noticed that DEIDRE WEEK was in the ditch, south by his neighbors.

RANDY BERKHOLTZ stated that when he got to where DEIDRE WEEK's body was he noticed that DAVID WEEK was cradling DEIDRE WEEK in his arms. He said that after being at the scene, DAVID WEEK got up and he (BERKHOLTZ) put the blanket he brought on DEIDRE WEEK. He said that he took DEIDRE WEEK's hand and attempted to find a pulse, without success. He also commented that DEIDRE WEEK's hand was cool to the touch. He also described DEIDRE WEEK's injuries, stating that she had one eye open and had dried blood by her nose and ears. It should be noted that he made no comments about any injury to DEIDRE WEEK's head.

RANDY BERKHOLTZ continued, stating that he also noticed a bicycle in the east ditch, which was north of DEIDRE WEEK's body. He provided no other information regarding the bicycle at the time of this interview.

S/A Rehrauer then asked RANDY BERKHOLTZ if he saw anything else while at the scene, aside from law enforcement and rescue personnel. He did state he saw a pair of blue jeans on the roadway. He said he was somewhat confused as to whether these jeans were DEIDRE WEEK's or not.

RANDY BERKHOLTZ recalled that shortly after he arrived at the scene, where DAVID WEEK was with his daughter, DEIDRE WEEK, and MATT MOLNAR, DAVID WEEK got up and said he had to get a hold of his wife. He stated that after DAVID WEEK made this statement, he noticed WEEK get into his vehicle on the west side of the roadway and drive south toward Vesper. He said he did not recall seeing DAVID WEEK go past the accident scene shortly after, northbound.

RANDY BERKHOLTZ then stated he heard the Vesper First Response Unit coming so he went up on the roadway to flag them down. He said during this same period of time, or shortly thereafter, JAMES VRUWINK returned to the scene. He said that VRUWINK's first comment was "who moved the bike, it was in the middle of the road". He said that after JAMES VRUWINK made this comment to him he told JAMES VRUWINK that it was in the ditch when he arrived. He also stated that VRUWINK did tell him that he had seen the accident and

had turned around and chased the vehicle which struck DEIDRE WEEK, but couldn't catch it.

S/A Rehrauer then questioned RANDY BERKHOLTZ as to whether DAVID WEEK made any other statements that he could recall about the accident involving DEIDRE WEEK. He said none that he could recall.

S/A Rehrauer then asked RANDY BERKHOLTZ if he could recall any other traffic going by, either north or south after he heard the thud while he was sitting in his residence. He stated to the best of his recollection he had not.

Following the interview S/A Rehrauer, Inv. Reichert, and RANDY BERKHOLTZ returned to the scene of DEIDRE WEEK's accident so he could point out where he observed DEIDRE WEEK's body and bicycle on 03/24/95. The following reflects his recollection:

DEIDRE WEEK's body was located in the east ditch of County Trunk HH, 24 paces north of center of LORRIE GRIFFITH's driveway, 6794 County Trunk HH, Vesper, WI, which would be in the area of the memorial marker for DEIDRE WEEK. He did state that some of DEIDRE WEEK's body was in the bottom of the ditch and he indicated that her head was facing southeast and her legs were facing northwest. He also recalled that DEIDRE WEEK may have been wet from lying in the ditch as there was water in it on that date.
- 2. DEIDRE WEEK's bicycle was located on the east side of County Trunk HH in the down slope of the ditch approximately 36 paces south of the middle of his driveway located at 6824 County Trunk HH, Vesper, WI.

The contact with RANDY BERKHOLTZ was concluded at 2:20 p.m.

I ran out to the end of our driveway and seen that they were in the ditch wor of our neighbors to the south. Upon arrival Dave was holding Deidue in his arms. He got up as I put the blanket on her and shorted checking for a pulse. nave said he had to get his wife and left driving to the south thought his wife was home not working or I would of Kept him at the scene.

The bike was laving in the east ditch about 100 ft. RI

and Matt sent her back to the house to call 911 again to notify them that it was a hit-and-run.

Vesper First-Response was coming so I went uponto the road to flag them down. Some place in this area of time, Jim Unwink came back. I don't recall it it was before on after First-Response annived.

The first thinks I'm said was. "Who moved the bike? It was in the middle of the road!" I told him it was in the ditch when I arrived. He told me his name and proceded to tell me he seen the accident, turned around and chased the vehicle but couldn't catch it.

By this time County Officers were arriving. They took Jim to the side and guestioned him. They asked the if I seem anything and I responded with a no. This was the only time any of us four was guestioned by the officers the ambulence Sollowed by the flight-for-like arrived. I stayed around til most everyone had left, the went home.

Our neighbors pretty much keep to themselves in our area, including myself. It was the first time I had met Deidne, but I'll never forget her. My sympathy goes out to the family. It's brought us all alot closer together It's too bad it usually takes a tragedy like this in the world to day to do this.

On Friday, September 8, 1995, at 2:30 p.m., S/A John M. Rehrauer and Inv. Thomas Reichert of the Wood County Sheriff's Department met with and interviewed ROBERT and MARJORIE LOONSTRA at their residence, 7659 County Trunk HH, Arpin, WI. The purpose of this interview was to comply with the request which ROBERT LOONSTRA had made on 09/07/95.

Initially ROBERT LOONSTRA stated that he was still having some difficulty with JAMES VRUWINK and mentioned that on the previous day, 09/07/95, when he stopped to see the investigators he was upset because JAMES VRUWINK was staring at him again. He said since stopping to see the investigators he has calmed down and was dealing with the situation better.

MARJORIE LOONSTRA then stated that she had some additional information to provide to S/A Rehrauer. She said that she now recalled that TRACY STALTER at one time had been driving a black 2dr. vehicle with a slant back. Based on conversation between both ROBERT and MARJORIE LOONSTRA, it was felt possibly this vehicle was She further stated she was unsure of whether TRACY STALTER was driving this particular vehicle on 03/24/95 but knew MS. STALTER was driving this type of vehicle during that general time frame.

MARJORIE LOONSTRA also stated that on the weekend of DEIDRE WEEK's accident she noted that TRACY STALTER and JAMES VRUWINK left their residence on Saturday morning and returned home on Sunday at about She also mentioned that she believed that JAMES VRUWINK had his children on that weekend.

They also reported that on or about June 1, 1995, someone They provided the following detail impersonated ROBERT LOONSTRA.

regarding this particular situation. ROBERT LOONSTRA said he had been invited to appear on Channel 7 to provide information as to what he saw on 03/24/95. He said he declined to appear. He did say that DAVID and BRENDA WEEK, LORRIE GRIFFITH, MARY SCHULTZ, and the BERKHOLTZS did appear.

ROBERT LOONSTRA stated that after he declined the offer to appear on Channel 7 someone did contact Channel 7 and advised that he (LOONSTRA) did want them to come to his house so he could provide an account of what he saw on 03/24/95. He said he never did this and was unaware of who did.

In concluding this contact S/A Rehrauer did inform the LOONSTRAs to ignore JAMES VRUWINK's stares and go about their business.

The contact with the LOONSTRAs was concluded at approximately 2:45
